01	Travellers Details <ul style="list-style-type: none"> Original Valid passport with at least 6 month validity from the date of travel along with all old passports. Photo dimensions: 2.5 x 2.5 on matte finish paper with white background. Electronic Visa Form to be online by applicant. Aadhar card or Pan card
02	Travel Details <ul style="list-style-type: none"> Copy of confirmed Arrival and Departure tickets Confirmed Hotel reservation showcasing the Hotel Address, Contact Number, Applicant's Name and Dates of Reservation for all days of travel
03	If Employed <ul style="list-style-type: none"> Provide the following company letters on official letterhead, including the applicant's name, designation, and signature of the authorized signatory (The Visa Officer, Embassy of Turkey, Delhi): <ul style="list-style-type: none"> Leave Sanction letter (OR) No Objection Certificate. Payslips of last 3 months. Company Appointment Letter (if the applicant has recently switched the company). 3 years' ITR or Form 16 (Part A & Part B) is required. Personal bank statement should be for the last 6 months with the bank's sign & Closing Balance should be INR 2 Lakhs per applicant.
04	If Self-employed <ul style="list-style-type: none"> Cover Letter on official business letterhead including the applicant's name, designation, and signature of the authorized signatory. (The Visa Officer, Embassy of Turkey, Delhi) Valid proof of Business Registration Certificate, such as GST certificate, Certificate of Incorporation, Partnership Deed, MOA, etc. For Partners, LLPs, or Directors: Business ITR for the last 3 years is required along with personal ITR For Self-Employed Individuals: 3 years' Personal / Company ITR Personal bank statement should be for the last 6 months with the bank's sign & Closing Balance should be INR 2 Lakhs per applicant.
05	Specific Mandates <ul style="list-style-type: none"> All documents should be in English. If a document is in any other language, an official translation of the same should be submitted. Embassy or Consulate may request additional documents or personal interview with the applicant on a case-by-case basis.
06	If Student <ul style="list-style-type: none"> Bonafied certificate from educational institution Leave letter from the student's educational institution Student identity card copy
07	If Retired <ul style="list-style-type: none"> Retirement proof or Pension slip for the last 3 months
08	If staying with friends and family <ul style="list-style-type: none"> Name/passport number of invitees Duration/purpose of stayColored copy or original invitation letter Inviting person's signature ID/passport Inviting person's permanent address & contact number
09	Specification for eVisa <ul style="list-style-type: none"> A copy of a valid visa or residence permit for the Schengen Area (only for multiple entry visa & residence permit), the USA (only for B1/B2 & green card holders), the UK, or Ireland.
