Obtain a new passport if your current one does not meet such criteria.) • All previous Old and cancelled original passport required while submitting the application. • One clear Coloured printout of online filled Visa Application Form - Application form must be fully filled and signed by the applicant. (Please not additional charge is applicable in case forms is filled by "Us".) • Recently clicked 02 Photograph of 35*45 mm with white background + 02 original are to be sent with the application • Clear scan copy of applicant Aadhar card is mandatory. • The applicant's name must match exactly same on both current passport and Aadhar card. • In case of any mismatch in the applicant's name in any of the government documents, applicant is requested to submit a name correction affidavit. • Any letter or document using for china visa application must maintain a consistent font throughout and the date must follow the YEAR- MONTH- DATE format.
02	<p>If Business</p> <ul style="list-style-type: none"> • Original cover letter or Visa Request letter from the Employer or traveller on its company letter head. <ul style="list-style-type: none"> ◦ The letter must include the details i.e. ◦ Company background briefing, purpose of visit, arrival and departure dates, ◦ Invitee contact details, traveller designation etc. and must be signed and stamped by the authorized person of the Indian company. ◦ Please note Cover letter or Employer letter must be addressed to "The Visa Officer, The Embassy of People's Republic of China, New Delhi, India". The cover letter must maintain a consistent font throughout and the date must follow the YEAR- MONTH- DATE format. ◦ Copy of Invitation letter from China with name and designation of Signing Person/Authority. ◦ The invitation should not be older than 1 month from the date of depositing the application and should have the Chinese red coloured rubber-stamp on the same. ◦ It is suggested to submit the invitation in both Mandarin and English language and the host name, signature and designation in the given invitation letter must be in Chinese. • The INVITATION letter must be addressed to "The Visa Officer, The Embassy of People's Republic of China, New Delhi, India"- <ul style="list-style-type: none"> ◦ The Invitation letter must maintain a consistent font throughout and the date must follow the YEAR- MONTH- DATE format. ◦ Clear Copy of valid Chinese Company Registration Certificate/Trade License- Business license need a water mark containing the purpose and the applicant's information the water mark must include the passenger Name and Passport no and purpose of travel. ◦ The License water mark MUST BE HAND WRITTEN In Chinese Language along with the date and Signature of the Invitee person. ◦ Clear copy of Valid ID proof of the invitee the id must include copy of both sides on same page of Signing Authority who has signed the Invitation letter. ◦ Please note that the Invitee passport copy is not acceptable by the Chinese embassy as an ID. ◦ The invitee Id must have a minimum validity of 06 months at the date of filling- Inviter id need a water mark containing the purpose and the applicant's & information the water mark must include the passenger Name and Passport no and purpose of travel. Letter should be addressed to "The Visa Officer, The Embassy of People's Republic of China, New Delhi, India". The invitation letter must maintain a consistent font throughout and the date must follow the YEAR- MONTH- DATE format. • Inviting person's permanent address proof. • Inviting person's contact number. • Inviting person's government issued ID front & back. • Proof of relation with person you are visiting • Valid China visa copy of person you are visiting • Self-attest cover letter or Visa Request letter from the traveller.
